

OBJECTIVES



GISBURN AUCTION MART'S objective is to encourage young people (under 27 years old), the future of our industry, to buy and sell cattle through

the live auction ring and to gain experience and business skills in the art of showmanship. The tasks of selection, feeding and presenting animals for show and sale are essential for the future well being of the beef industry.

Young people are offered the opportunity to purchase cattle (interest free) at any Gisburn August, September, October and November sales, feeding them through the winter to then return to auction to offer them for show and sale at the Gisburn Spring Store Cattle Sale.

The Competition is about keeping the skills of stockmanship alive and thriving. The high standards each competitor strives for and the knowledge gained to take them into their adult working life is a lasting legacy.



HOW TO ENTER

Register yourself in person at the auction mart and your intent to buy for the competition.

Fill in the entry form and pay the entry fee of £10

If you are under 16 years of age a parent must sign.

BUYING DATES

From Thursday 2nd August 2018 To Saturday 24th November 2018



RULES

1.	The competition is open to all young people aged 27 and under as at 1st March 2019.
2.	The stock must be purchased by the competitor in person at any Thursday calf, stirk or Saturday store sale conducted at Gisburn Auction Marts Ltd between 2nd August 2018 and 24th November 2018 inclusive.
3.	Participants must register their animals on the day of purchase with Ann Faraday or Rachel Capstick at the main auction office by completing an entry form and paying the £10 non-refundable entry fee per animal . The office will then record the purchase date, weights and prices of the animal(s).
4.	Each competitor may enter a maximum of 2 cattle (cannot be shown in the same class) however, only the first animal will be eligible for finance by Gisburn Auction Marts Ltd. Any second animal to be purchased at the competitor's own expense and paid for in full within ten days of the date of purchase.

5.	Each entry must be prepared and shown by the competitor , therefore each competitor can only have one entry in each class.
6.	The stock must be overwintered by the competitor or his/her employer and must be available for inspection on the farm at any time, by the organisers.
7.	The stock must be presented for show on the evening of Friday 1st March 2019 at Gisburn Auction (judging time to be confirmed) and offered for sale by the competitor at Gisburn Auction Marts Spring Show & Sale on Saturday 2nd March 2019.
8.	All animals must be halter-led to compete in the show classes. Unhaltered cattle will be included in the competition for daily live weight gain and gross margin but will <i>not</i> be eligible for show.
9.	Judges will be appointed by Gisburn Auction.
10.	The competitor or competitors' guardian (if competitor is under 18 years old) is responsible for any loss or injury to the animal and are responsible for reimbursing Gisburn Auction Marts Ltd. the purchase price.
11.	Cattle withdrawn from or not sold at the sale will forfeit all prize money and payment of the purchase price plus 5% will be payable.
12.	Female cattle must be 'clean' and warranted free of the bull. Cows, calved heifers or in-calf heifers will <i>not</i> be eligible for the competition.
13.	In the case of cattle purchased using Mart finance, Gisburn Auction Marts Ltd will pay over to the competitor, the balance between the sale proceeds and the original purchase price minus the normal 3% Auction Mart commission plus VAT.
14.	Any shortfall between the sale price and purchase price must be paid over to Gisburn Auction Marts Ltd by the competitor.
15.	Gisburn Auction Marts Ltd Directors will be the sole arbiter of these or any amended rules.

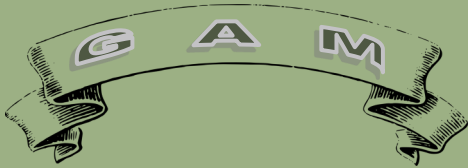
